Ludwigsburg, 05 August 2008. In the first fiscal quarter ended on 30 June 2008, Jetter AG (ISIN: DE0006264005) reached the highest quarterly sales in their history, namely 13.2 Mio. Euro, 18% more than the 11.2 Mio. Euro the year before. EBIT also set a new record at KEUR 1,609 (previous year: KEUR 1,482). Earnings per share were EUR 0.48 against EUR 0.37 in the previous year.

Since some major customers will close for some time during summer, sales for the second quarter are expected to be slightly lower; the guidance for the whole year is therefore not adjusted. Management continues to expect a double-digit growth, with the target of a 10% EBIT margin.
