Sponsor und Springer-CEO Mathias Döpfner dürfte das freuen, will er doch mit aller Macht seinen Anspruch als weltgewandter Digitalimpresario unterstreichen. Rodzynek verdichtet das zweitägige Programm, indem er den meisten Rednern kaum mehr als zehn Minuten lässt. Für Mitte November in London haben bereits Investor Klaus Hommels und Metro-CEO Olaf Koch zugesagt.

PLATZHIRSCH: DLD (MÜNCHEN) Die von Burda organisierte DLD (Digital Life Design) ist das traditionsreiche Dickschiff unter den Digital-Konferenzen der Alten Welt. Geschäftsführerin Steffi Czerny hat mit einer Mischung aus Hartnäckigkeit und bajuwarischer Herzlichkeit schon Mark Zuckerberg (Facebook), Marissa Mayer (Yahoo) oder den legendären Napster-Gründer Sean Parker ins HVB-Forum gelockt. Neben Czerny tut der israelische Gründerpate Yossi Vardi sein Bestes, um das Gästenniveau zu halten und die Marke über den Globus auszubreiten: Mittlerweile gibt es Nebenevents in Tel Aviv, Peking, Rio de Janeiro oder Istanbul. Die DLD in München hat sich klugerweise ein paar Tage vors Weltwirtschaftsforum in Davos geschoben – für viele gehören die Veranstaltungen längst zusammen.

ABSTEIGER: LEWEB (PARIS) Lange Zeit war sie die Königin unter Europas Tech-Konferenzen, doch in diesem Jahr setzt die Pariser LeWeb überraschend aus. Dabei schwärmen noch heute viele von den alten Zeiten: Wer es sich leisten konnte (Tickets kosteten bis zu 2300 Euro), plauderte am Büfett mit Instagram-Schöpfer Kevin Systrom oder nahm abends mit Twitter-Gründer Jack Dorsey einen Drink an der Bar. Ebenfalls dabei: analoge Gäste wie Modezar Karl Lagerfeld oder Starkoch Jamie Oliver. Zuletzt kamen 3500 aus der ganzen Welt. Initiator ist der Internetunternehmer und Sarkozy-Berater Loïc Le Meur. 2016 soll es weitergehen – was manche bezweifeln. Sie lästern, die LeWeb sei zum Showroom für US-Start-ups verkommen und habe so den Anschluss an Europas Szene verloren.

NEWCOMER: BITS & PRETZELS (MÜNCHEN) Es braucht mittlerweile gehörig Spezialeffekte, um als Neuling noch Gäste anzulocken. Im Januar dockten die Veranstalter von Bits & Pretzels terminlich noch an die DLD an, Ende September mieteten sie für den dritten Konferenztag gleich ein ganzes Zelt auf dem Oktoberfest. Eigentlich ein Ding der Unmöglichkeit, doch das Team um die Gründer Andreas Bruckschlägl, Bernd Storm (Onpage, Aboalarm) und den Investor Felix Haas (Kreditech, Amiando) wusste höhere Mächte an seiner Seite: Wirtschaftsministerin Ilse Aigner (CSU), die Bayern zu Deutschlands Valley machen will. Es kamen Adidas-CEO Herbert Hainer, Ex-McKinsey-Boss Herbert Hentzler, „Bild“-Chef Kai Diekmann und Niklas Östberg (Delivery Hero) – das Event blieb also eher national. Zwei Maß und ein Hendl waren inklusive, Redner traten in Lederhosen auf. Provinzieller geht es kaum, trotzdem wollen die Veranstalter über 3600 Karten verkauft haben – respektabler Erfolg und Hypesymptom zugleich.
