Data Privacy

1. Granting of consent (in accordance with Art. 6 EU GDPR)

- a) Any personal data is provided on a voluntary basis. I have no legal or contractual obligation to provide my data.
- b) What happens if I do not give consent:
Individuals failing to provide personal data will not be admitted to the event.

2. Right to object (in accordance with Art. 21 EU GDPR)

I have the right to withdraw my consent at any time with future effect. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

3. Further processing

- a) The legal basis for the purpose of processing data as specified above is the consent given in accordance with Article 6(1)(a), Article 7 EU GDPR.
- b) Data will be stored no longer than three months after the above-mentioned event.
- c) The data will be forwarded to the Federal Criminal Police Office for security reasons in accordance with §§ 5, 10, 14, 25 of the Federal Criminal Police Office Law or to the responsible state criminal police office in accordance with relevant state police laws.
- d) No automated decision-making will take place.
- e) The data will be processed as follows: They will be stored in an EXCEL spreadsheet and will be deleted as soon as they are no longer required.
