Mr. Ludwig Merckle, Germany, has notified us on 13 October 2009, as a correction to his notification of voting rights pursuant Art. 21 para. 1 German Securities Trading Act dated 6 May 2009, of the following:

"Hereby I notify you pursuant to Art. 21 para. 1 German Securities Trading Act, that my voting rights in HeidelbergCement AG on 5 January 2009 (day of my father Adolf Merckle's death) went over the thresholds of 3%, 5%, 10%, 15%, 20%, 25%, 30%, 50% and 75% and on that day amount to 79.52% (99,397,749 voting rights).

Out of these 79.52% of the voting rights (99,397,749 voting rights) are assigned to me pursuant to Art. 22 para. 1 sent. 1 no. 1 German Securities Trading Act.
