- 1. The holding entity of Morgan Stanley Bank AG, Frankfurt, Germany, Morgan Stanley International Holdings Inc., Wilmington, USA, on 25 September 2009, has fallen below the thresholds of 10%, 5% and 3% of the voting rights of HeidelbergCement AG, Heidelberg, Germany, and on that day holds 1.29% (2.412.994 voting rights) of the voting rights whereby the aforementioned voting rights have to be attributed pursuant to Sec. 22 para. 1 sent. 1 No. 1 German Securities Trading Act; and that

The holding entity of Morgan Stanley International Holdings Inc., Wilmington, USA, Morgan Stanley, Wilmington, USA, on 25 September 2009, has fallen below the thresholds of 10%, 5% and 3% of the voting rights of HeidelbergCement AG, Heidelberg, Germany, and on that day holds 1.45% (2.713.044 voting rights) of the voting rights whereby the aforementioned voting rights have to be attributed pursuant to Sec. 22 para. 1 sent. 1 No. 1 German Securities Trading Act.
